TERMS AND CONDITIONS OF SCHOOL BUS SERVICES

1. Parent/guardian requiring the service of the school bus must submit an official application.
2. School Bus Owner shall only charge the bus fare according to the “not to exceed” fare in the respective distance range and bus capacity.
3. Daily School Bus Services:
 - a) Bus fare for the Daily School Bus Services is based on the Distance Range, Bus Seating Capacity and either One or Two Way trip between the school and the pick-up/drop-off points. The returned trip from school to the drop-off point is for the normal school dismissal at 1.00pm/1.30pm.
 - b) Bus fare is payable in advance within the first school week of every month of the calendar year except in the months of June, November and December, there is no fare to be payable.
 - c) Arrival time at school must not be earlier than 6.30am, and the departure time from school will not be later than 1.40pm on Monday, Tuesday, Thursday and Friday and not later than 1.10pm on Wednesday.
4. After-School Activities Bus Services:
 - a) Only the parent/guardian who has engaged either the one or two way bus service provided by the school bus owner is allowed to take the after-school activities bus service at 4.00pm.
 - b) Bus fare for the after-school activities bus service is payable in advance within the first school week of every month of the calendar year except in the months of June, November and December, there is no fare to be payable.
 - c) No fare is also payable for the months where the pupil did not take the after school activities school bus services.
 - d) Departure time from school will not be earlier than 4.00pm and not later than 4.10pm.
5. Engagement of the school bus service shall be for ONE school year or till the end of the school year.
6. Advanced notification of at least 1 month must be served by either school bus owner or the parent/guardian in writing for cancellation or termination of school bus service. Failing to give advance notice, the parent/guardian shall pay one-month bus fare in lieu of the notice.
7. Pick-up and drop-off points and time shall be agreed upon between the parent/guardian and the school bus owner. Pupils must wait at the pick-up points at least 5 minutes before the pick-up time.
8. Parent/guardian engaging the school bus service will be issued a Bus Service Card. This card is for the record of bus fare payment and shall also serve as receipt of payment. It shall be produced to the bus owner when making payment. Parent/guardian must ensure that the payment is acknowledged by the bus owner in the card when it is made.
